INSURANCE:

Each individual vendor setting up at the event is responsible for securing his or her own insurance coverage. Mad Angel Entertainment and Miss Gay America is not responsible for any damage to equipment or bodily injury or death in any accident or event. Policy should include Miss Gay America, the venue, and the event dates.

ELECTRICAL INSTRUCTION:

Power is not always available at venues. We will do our best to work with vendors needing power at their tables.

PROFESSIONAL CONDUCT AND CONCESSION APPEARANCE:

No activities in violation of federal, state, or local laws shall be permitted on the premises; and it shall be the responsibility of the Vendor to enforce this provision. No lewd or indecent actions, conduct, language, pictures, or portrayals shall be included in the activity presented by the Vendor on the premises; and nothing shall be presented, used, or sold that is contrary to law or prohibited by ordinance of the local city and state.

COPYRIGHT INFRINGEMENT ACTIONS:

Should Vendor present or allow the presentation of any composition, work, or material covered by copyright, or furnish any product covered by registered trademark, the Vendor agrees to defend, indemnify and save harmless the Mad Angel Entertainment and Miss Gay America, their agents or employees, for any loss, damage, or expense arising from any claim, allegation or suit for infringement of such copyright or registered trademark.

CITY NOT LIABLE FOR LOSS OR DAMAGE:

Mad Angel Entertainment and Miss Gay America shall not be liable for any loss or damage to machinery, equipment, merchandise, paraphernalia, costumes, clothing, booths, stands, exhibit materials, or any other property of the Vendor, or Vendor's agents, employees, patrons, or guests, caused by theft, riots, strikes, civil commotion, fire, acts of nature, shall not be responsible for charges or expenses on any materials, merchandise, properties, printed or advertising matter or otherwise, delivered for the Vendor.
